Please report to the Clinic fasting 1 hour before the treatment.		
Please take your medication before coming to the Clinic (except for drugs against diabetes)		
Please take your medication to the Clinic.		
Please apply drops to the eye recommended by the attending doctor 2 days before the procedure.		
If the Patient applies anti-glaucoma drops, they must not be discontinued.		
Please provide results and descriptions of recommended examinations.		
Please bring your medical records on chronic diseases and allergies, as well as information cards from hospital stays.		
Please bring the doctor's certificate of the lack of contraindications to procedure under local/general anaesthesia.		
After consultation with your doctor, discontinue medication 5 days before the operation: Aspirin, Acard, Acesan, Polopyrin.		
Patients taking medication from the vitamin K antagonists group (e.g. Sintrom, Warfarin, Acenocumarol) after consultation with your doctor, should discontinue usage of those medicines 5 days before surgery and during this time take injections from the low molecular weight heparin. NOTE: In the morning on the day of the operation, please do not make an

injection with low-molecular-weight heparin (Clexan, Fraxyparin). This injection should be made on that day in the evening.		
Please perform laboratory tests and show the results to your doctor before the surgery in the Clinic. Pre-ophthalmological laboratory examination package (Morphology, glucose, ESR, Na, K, INR, Creatinine).

DAY BEFORE THE TREATMENT:

1. Bathe the whole body and wash your hair.

ON THE TREATMENT DAY:

1. The patient remains fasting for at least 6 hours before surgery (do not eat breakfast and drink a minimum amount of water). Patients who are scheduled to come to the Clinic after 12:00 p.m. can have breakfast until 8:00 a.m. that day and then stay fasting.
2. It is necessary to take chronic internal medicine according to the schedule established with an anaesthesiologist and take medications with you to the Clinic.
3. We ask to report for the operation without make-up, painted nails and jewelry.
4. For a period of 6 weeks after surgery patient should not travel, stay in sanatorium or plan important tasks at work, undergo any other procedures or do any physical exercise (including rehabilitation). Attendance at special ceremonies is also not advised - during that time any alcohol consumption is strictly prohibited.

YOU MUST BRING:

1. Results of blood tests.
2. Certificate from patient's GP that there are no contraindications to the surgical procedure.
3. Certificate from the dental surgeon that there are no contraindications to the surgical procedure.
4. All hospital discharges (if there are any).
5. List of taken medicines.
6. If the patient is chronically treated in specialist clinics such as cardiology, diabetology, endocrinology, dermatology, oncology and laryngology – we ask to provide certificate of no contraindications to the surgery.
7. If the patient has inflammatory conditions of nose, ears or sinuses, you must have a certificate from your ENT doctor stating that you have no outbreaks of infection.
